Mere document verification or medical examination does not entitle the candidate for empanelment for job or recruitment, unless and until the offer of appointment is given.

IMPORTANT INSTRUCTION TO THE CANDIDATES FOR DOCUMENTS VERIFICATION

1. The candidates must bring the original call letter for document verification along with the lower portion of call letters of Written Examination.
 2. The candidates are advised to bring the following certificates (as applicable) in original along with one set of photocopies attested by Gazetted Officer:
 - (i) Educational qualification including Matriculation and Higher Secondary Mark sheets & certificates (every year or semester wise, 10+2 Equivalence Certificate) and ITI / Diploma / Degree certificate.
 - (ii) Matriculation / Higher Secondary certificate issued by Examination Board in support of Date of Birth.
 - (iii) Caste certificate in the prescribed format from the competent authority mentioned therein, for SC/ST/OBC candidate. OBC candidate should submit the current year Caste Certificate.
 - (iv) Discharge certificate (Applicable for Ex-serviceman only.)
 - (v) PWD certificate in the prescribed format including Typing exemption certificate, if applicable.
 - (vi) No Objection Certificate NOC (Applicable for serving employees in any Govt. Deptt. or PSU including Railways.)
 - (vii) One colour photograph, preferably as pasted on the application form.
 - (viii) Proof to be submitted by Widow/Divorcee/Judicially separated women from husband but not remarried and seeking age relaxation.
 - (ix) Necessary affidavit for variation in candidate name / father name / initials etc in the prescribed format.
- Note:** The prescribed formats specified above can be downloaded from rrbappreg.net or RRB websites
3. Railway Recruitment Board reserves the right to cancel the candidature of the candidates who fail to submit the original certificates as asked for in Para 2 above.
 4. If the candidates do not satisfy any conditions of the eligibility, the Railway Recruitment Board, reserves the right to disqualify them at any stage of selection.
 5. SC & ST candidates are eligible for free Railway Travel authority for To & From journey. All other candidates are expected to defray his/her own travelling expenses.
 6. In terms of Railway Board's order, RRB at its discretion may hold re-test if considered necessary for all or limited number of candidates as may be deemed fit by the Railway Recruitment Board at any stage of recruitment. You are therefore requested to come prepared for the same at the time of documents verification.
 7. Candidates are advised to plan for one /two more day(s) stay, if required.
 8. Candidates who adopt unfair means in the Railway Recruitment Board examination are liable to be disqualified and Railway Recruitment Board reserves the right to take legal action against such candidates.
 9. The request for change in the date of Document Verification will generally be not considered.
 10. Mere calling of the candidates for DV does not in any way entitle them for empanelment for job or recruitment in railways unless and until the offer of appointment is given.
 11. Candidate attempting to influence RRB directly or indirectly shall be disqualified and legal action can be initiated against them.

INSTRUCTIONS TO CANDIDATES APPEARING IN THE TYPING SKILL TEST

- (i) Typing examination will be conducted on Computer in English / Hindi as per the choice of the candidate. Candidates are requested to read the On-screen instructions carefully.
- (ii) The candidates are required to pass the Typewriting test at the minimum speed of 30 Words Per Minute in English or 25 Words Per Minute in Hindi.
- (iii) The candidates are required to type minimum 300 words or 1500 strokes so as to attain a minimum speed of 30 Words Per Minute in English Typewriting. Similarly, a candidate appearing in Hindi Typewriting should type minimum 250 words or 1250 strokes in order to attain a speed of 25 words per minute. The duration of the test is 10 minutes. The transcripts of those candidates who do not type out 300 words/1500 strokes in English or 250 words / 1250 strokes in Hindi in the prescribed time will not be evaluated. The standard measure adopted in counting words is @ 5 strokes per word.
- (iv) Candidates must start typing from the starting of the text and must complete the whole text. If any candidate finishes the text before the allotted time, he/she should restart the same passage and continue typing until expiry of the time.
- (v) The evaluation of the passage typed by the candidate will be done as follows:-
- (a) The mistakes will be classified as full mistakes and half mistakes. (5% mistakes of the total words typed may be ignored).
Accordingly, the total number of mistakes will be calculated as-
- $$\text{No. of full mistakes} + \frac{\text{No. of half mistakes}}{2}$$
- (b) The typing speed of the candidate will be worked out by the following formula:-
As per formula: $\frac{\text{No. of total words typed} - (\text{No. of mistakes} \times 10)}{\text{Time}}$
- (vi) The candidates must return the question paper along with their scripts to the invigilator after the examination is over duly signed. They should not take out of the examination hall either the question paper or scripts or any other blank typing paper. They should not tear any sheet given to them.
- (vii) **Physically handicapped candidates are eligible for exemption from typing qualification for appointment to clerical posts if they are found otherwise qualified and (are certified as being unable to type by the Medical Board attached to Special employment Exchange or by a Civil Surgeon where such a Board does not exist). Candidates seeking the exemption must be present with the above certificate on the date of typing test. Candidates remaining absent on the date of typing test will be disqualified for concerned posts.**

(viii) More number of candidates than the vacancies are being called for typing test and merely calling a candidate for typing test does not in any way entitle him/her to an appointment in the Railways.

(IX) The process of Document Verification of the candidates will be held alongwith the typing test. All the candidates therefore, must read the instructions for document verification carefully and come prepared accordingly.

(x) The above instructions are indicative. Instructions will be followed which are in vogue at the time of examination.
