The additional 50% Extra candidates are called as standby candidates and they will be considered for empanelment only if there is shortfall in empanelment from the main list.

Candidates are being individually intimated. However, RRB will not be responsible for the postal delay or wrong delivery, if any.

The candidates are required to bring all their original marksheets and certificates including the original disability certificate issued by the Competent Authority. The candidates must produce their original matriculation certificate for verification of date of birth, Disability certificate and Degree marksheet & certificate from a recognised University on the day of verification without fail. If any of the above candidates does not receive the call letter, the candidate may check the Railway Recruitment Board's notice board/website and attend the document verification strictly on the specified date indicated along with all documents.

The candidates belonging to SC/ST & OBC should bring their original caste certificate in prescribed format. In case of OBC candidates the caste certificate should be current and not more than one year old and should have clause of Non-Creamy Layer.

Candidates should bring their original call letters of (i) First Stage Written Examination, (ii) Second Stage Written Examination, (iii) call letter for Document Verification. The Candidates should also bring photocopies of all the original certificates and documents including the original disability certificate issued by the Competent Authority for Document Verification. Any candidate coming for the verification without complete documents will be asked to return and their candidature shall be liable to be cancelled.

Merely calling the candidates for document verification will not confer on them the right for employment in any Zonal Railway/Railway Organisation.

While every care has been taken in preparing the result, the Railway Recruitment Board reserves the right to rectify errors and omissions if any.
