- 1.0: Candidates bearing the Roll Numbers listed herein under have been provisionally shortlisted for the Replacement Document Verification (RDV 2) for the posts notified in Pay Level – 6, based on the 2nd stage CBT and Aptitude test and the priority for various posts furnished by them in the online application. This list of shortlisted candidates for RDV 2 is published in the websites of RRBs, subject to availability of eligible candidates.
- 2.0: The Replacement Document Verification (RDV 2) will be held on 11.06.2024 and Block date for absent candidates is on 18.06.2024. The candidates scheduled for RDV 2 will get an email to download their e-call letter from RRB Mumbai Website.
- 3.0: Candidates may note that after successful completion of RDV 2, they will have to undergo Initial Medical Examination at the nominated Railway Hospitals located in the jurisdiction of RRB Mumbai. The candidates are required to come prepared to stay for three to four days. Candidates have to pay the prescribed medical fee of Rs.24/-. Accordingly, candidates have to come prepared for RDV 2 and medical examination.No second chance for initial medical examination will be given if the candidate remain absent on the schedule date for the medical examination.
- 4.0: The shortlisted candidates for RDV 2 should produce all the original documents along with one set of Xerox copies in A4 size as detailed in the CEN and e-call letter.
- 5.0: Candidature of all the shortlisted candidates for Document Verification is purely provisional and is liable to be cancelled, at any stage of recruitment or thereafter, in case of any inconsistency / deficiency in the data furnished by them in their online application or any malpractice on the part of candidates coming to the notice of RRB at any stage of the recruitment process. It may be noted that merely calling a candidate for Document Verification does not entitle him/her in any way to an appointment in the Railways.
- 6.0: While every care has been taken in preparing the list of candidates shortlisted for Replacement Document Verification 2, RRB reserves the right to rectify any inadvertent error or typographical/printing mistakes. RRB regrets for the inability to entertain any correspondence from unsuccessful candidates.
- 7.0: Important: Beware of the touts who may misguide the candidates with false promises of getting them selected for the job on illegal consideration. The recruitment process in the RRB exams is fully computerised and the selection is based purely on the merit of the candidates.
- 8.0: Candidates are advised to regularly visit RRB's official website for the updates.
